a) Final Tombraisers Report

Report on the Tombraisers' Committee to Luckington and Alderton Parish Council

Even though the Committee has not reported to the Parish Council since April 2019 things have been happening in the background and we are happy to report that a grant from the Heritage Lottery Fund has been awarded for the restoration of seven chest tombs in Luckington Churchyard. Four of these tombs are currently encased in wire cages and when the work has been completed the wire cages will be removed. The contract for the restoration work has been awarded to James Long Stonemasons who are scheduled to start work in mid-September. It is estimated that the work will take three weeks.

We are immensely grateful to the Heritage Lottery Fund for responding to our plea for funding which will amount to 80% of the project costs. However, we cannot emphasise highly enough the importance of the support that the LAPC and the local community gave to the project by their donations at the very start. We are also grateful to Councillor Thomson for promoting the project with Wiltshire Council.

As mentioned in an earlier report the Heritage fund differs from other grant making bodies in that an award of a grant brings with it the requirement to demonstrate that a wider range of people will be involved in heritage. The Tombraisers' Committee has put together an exciting range of activities centred on the local history of Luckington and these events will take place over the next twelve months. These will be widely advertised locally including in Community Matters.

As we have now achieved our goal, I am going to propose that this should be our final report to the Council. We would be grateful if you could minute the sincere thanks of the Tombraisers' Committee to the Parish Council for their support throughout this process.
