1293. Update on grass cutting

(SE) presented the two quotes which had been submitted to the council, in response to the re-issued tender process. He proposed that the council accept the quote from J.D. Estate & Garden Management, which he felt was the best for both the community and council. This is a new contractor. (JB) seconded the proposal. Councillors approved the proposal unanimously with one abstention.

1294. Update on cemetery issues

RS and RMC visited the Cemetery and have proposed from next month to create one row of 14 and one row of 12 half size plots for internment of ashes, to be formally agreed at the next parish meeting and inviting any comments from the public.

They will be below the circle, but in line with the front of the trees to the fence.

1295. Update on highway issues

Sopworth Road drainage works are due to commence on the 8th April 2019.

The sunken drain cover on Alderton Road (Alderton to B4040 Ashbridge House) has been reported, and is awaiting repair by Wessex Water.

Fly tipping by Oldlands Wood on the Fosse Way (Grittleton Parish) is actively being addressed by Wiltshire Council.
