## 1135. Letter from Wendy Harris, Malmesbury League of Friends Re: Defibrillators

(VA) has asked the Chairman of Alderton Village Hall Committee, Hugo Armitage, if they would be interested in getting a defibrillator, ideally to be attached to the outside of Alderton Village Hall. He was keen to get one for the village and will investigate the costs of getting the hall electricity supply changed as it's currently on a meter. Parish Councillors were pleased with this outcome and look forward to hearing from Mr Armitage.

## 1136. Application for LAPC Community Grant from Friends of Luckington School

The Parish Council discussed this grant and were all happy that the application met all the Parish Council criteria and were all keen to support the school. (JB) proposed a cheque for £378.31 be drawn up and signed at this meeting (NN) seconded. All agreed.

# 1137. Email from Anne Pollard, Auditing Solutions Re: Annual Audit

(VA) explained to the PC that in the past there have been two yearly audits. An internal audit conducted by Auditing Solutions and an external audit done by Grant Thornton. The government have now appointed a new external auditor, PFK Littlejohn. However, as this Parish Council is classed as a smaller authority where the higher of gross income or gross expenditure has not exceeded £25,000 in the year ended 31 March 2018, it would be possible to certify as exempt from a limited assurance review. (JB) proposed that the PC certified as exempt as we met all the criteria for this. (NN) seconded and all agreed. (VA) will notify the auditors and prepare the paperwork to be signed at the PC meeting in April.

#### 1138. Update on Luckington Churchyard Tombstones

(SLM) has met with the Vicar and the Parochial Church Council. He would like to help them obtain the funds for the restoration of the tombstones. He shared with the PC the estimated costs for the project. (JB) highlighted again that the Parish Council isn't lawfully able to donate to a church project as it stands. However, as previously stated in meetings, they could possibly help if the tombstone project became an appropriately constituted 'legal entity' with registered charity status (as per the guidance available from The Charity Commission and the Department for Business Innovation and Skills) . (RS) suggested that (SLM)

could report back to the PCC that the Parish Council, in principle, would be prepared to donate to the restoration of the tombstones. (SLM) will do this and report back at the next meeting.

## 1139. Update on Luckington Cemetery

(RS) reported that the wall has been repaired however he can't cap the top yet as it has been too cold. He will do so when the weather improves.

#### 1140 Update on Highways

(JB) reported that the Parish Steward has been to the village recently and made sure that all the drains were clear.

Good news regarding the Sopworth Road drainage system. The finance for this project has been approved by Bristol Water and Wiltshire County Council. So look forward to the works starting soon.
