## 1861. To confirm the Minutes of the meeting held on 8th June 2022

#### 1863. Correspondence received:

a) Seb Lawrence-Mills (29/06/22) in regards to overgrown footpath and wobbly stile between Bridges Court and Sladebrook House. JB replied by email (01/07) advising SLM to report directly to Wiltshire Council via the app, as footpaths do not come under Parish Council responsibilities. Resolved with help of local landowner Jack Hodges.
