a) <u>PL/2023/00430</u>. SLADBROOK HOUSE, THE STREET, LUCKINGTON, CHIPPENHAM, SN14 6NT . Weeping Willow tree - crown reduction to previous pollarding points to reduce overshadowing and nuisance to pedestrians and traffic. No objection.

b) <u>PL/2023/00566</u>. 5 CHURCH ROAD, LUCKINGTON, CHIPPENHAM, SN14 6PG. T1 - Bay tree to be reduced/trimmed T2 - Willow tree to be pollarded T3 - Cherry tree to be trimmed and tidied. No objection.

1949. Update on Financial Issues

a) To agree payments as listed in the attached financial summary:

b) Barclays update. SB updated the Council on communication from Barclays about verifying the Council account details and signatories, ongoing since October. After a short discussion, SB to write to Barclays expressing

disappointment with their service to the Council as a public local authority since 1895 (part of government, not a business). SB to research alternative banks, directly and via NALC.

1950. Cemetery update including latest wall collapses

Further to the quote received from Robert Simpkins, in regards to the repairs needed (3 sections of the cemetery wall), the Council approved the work. SB to contact RS, funds to be allocated from cemetery pot. Cemetery tidy-up day – with the likelihood of further adverse weather, and in the absence of volunteers this is postponed until the spring (March).

SB updated the Council in regards to the land title, confirmation has been received from Loxley's Solicitors that the registration is in hand and will be processed imminently.
